## Louisiana Department of Health Bureau of Health Services Financing and Office of Behavioral Health

## Substance Use Disorder Waiver

The Louisiana Department of Health (LDH), Bureau of Health Services Financing, in collaboration with the Office of Behavioral Health, currently utilize institutions for mental disease (IMDs) as an alternative setting to inpatient general hospitals for individuals, ages 21-64, who are in need of substance use disorder (SUD) residential treatment in the Healthy Louisiana Medicaid Managed Care Program. Recently released federal Medicaid managed care regulations impose new limitations and costs on the Department's use of IMDs as alternative settings for State Plan behavioral health services.

As a result of the aforementioned federal regulations, the Department hereby gives public notice of its intent to submit a request to the U.S. Department of Health and Human Services, Centers for Medicare and Medicaid Services (CMS) to implement a Section 1115 Medicaid Demonstration Waiver in order to continue using IMDs as an alternative setting to inpatient general hospitals for individuals, ages 21-64, who are in need of SUD residential treatment and enrolled in the Healthy Louisiana Program. Implementation of this Section 1115 Medicaid Demonstration Waiver is contingent upon CMS approval.

The SUD Waiver will allow the following:

- Diversion of individuals from costly behavioral health admissions at general hospitals to more appropriate and cost-effective behavioral health treatment facilities; and
- Provision of medically necessary services in the most appropriate setting for the member, regardless of the length of stay.

In compliance with CMS regulations, the Department is posting the Section 1115 Medicaid Demonstration Waiver

Application for public comment from June 7, 2017 through July 7, 2017. CMS regulations require the Louisiana Department of Health to actively engage the public and give program participants, advocates, providers and other community stakeholders the opportunity to provide input regarding waiver applications prior to the submission of final versions to CMS.
